The acceleration of globalization has ushered in the era of unprecedented massive transboundary migration in the international society, with money and goods moving worldwide. Contemporary migration and the diaspora exist within a wide variety of backgrounds. These, for instance, include economic reasons, academic purposes, policy of national authority, and dire situations that force people to leave their homelands in a life-or-death crisis. In this symposium, participants discuss the implications of such global migration and its impact on the international society and human beings in general. By shedding light on the serious refugee crisis, especially in Syria and Bosnia, we will further exchange thoughts on the present challenges of humanitarian assistance and explore possible measures for its future development.

グローバル化が急速に進む中、国際社会は、モノ、カネだけでなく、ヒトが大規模に国境をこえて移動する時代を迎えています。こうした広義の人々の移動(migration)には、経済的理由、学問研究目的、国家の政策、紛争などによる生命の危険など様々な背景があります。本シンポジウムではまず、こうした人の越境移動が、国際社会・人類にとって如何なる含意があるかを議論します。その上で、次に、現下の深刻な難民問題に焦点をあて、シリア、ボスニアなど具体的なケースも取り上げつつ、人道支援の問題点などについて現状と事態改善のための方途に関し幅広く意見交換します。

Tsuneo NISHIDA, Director of Institute for Peace Science, Hiroshima University

After entering the Ministry of Foreign Affairs in 1970, Ambassador Tsuneo Nishida served important positions in various countries: First Secretary at The Embassy of Japan in the Union of Soviet Socialist Republics, Political Counselor at the Embassy of Japan in the United States of America, and Consul General of Japan in Los Angeles. Furthermore, he served as Deputy Director General of the European and Oceanic Affairs Bureau and as Director General of the Economic Cooperation Bureau in Tokyo. In 2002, Ambassador Nishida was appointed Deputy Vice Minister of Foreign Policy and Director General of the Foreign Policy Bureau. From 2005 to 2007, he was Deputy Minister for Foreign Affairs. In June 2010, Ambassador Nishida was appointed Ambassador Extraordinary and Plenipotentiary, Permanent Representative of Japan to the United Nations and prior to that he served as Ambassador Extraordinary and Plenipotentiary at the Embassy of Japan in Canada.

1970年に東京大学法学部卒業後、外務省入省。1999～2001年在ロス・アンジェルス日本総領事、2001～02年経済協力局長、2002～05年に総合外交政策局長、2005～07年に外務審議官(政務)、2007～10年に特命全權大使カナダ駐兼国際民間航空機関日本政府代表、2010～13年に国連日本政府常駐代表特命全權大使などを歴任。2014年4月より広島大学平和科学研究センター長(副総務長)。

David L. Phillips, Director, Peace-building and Rights Program, Institute for the Study of Human Rights (ISHR), Columbia University



Phillips has worked as a senior adviser to the United Nations Secretariat and as a foreign affairs expert and senior adviser to the U.S. Department of State. He has held positions as a visiting scholar at Harvard University's Center for Middle East Studies, executive director of Columbia University's International Conflict Resolution Program, director of the Program on Conflict Prevention and Peace-building at the American University, Associate Professor at New York University's Department of Politics, and as a professor at the Diplomatic Academy of Vienna. He has also been a senior fellow and deputy director of the Council on Foreign Relations' Center for Preventive Action, senior fellow at the Atlantic Council of the United States, senior fellow at the Center for Strategic and International Studies, director of the European Centre for Common Ground, project director at the International Peace Research Institute of Oslo, president of the Congressional Human Rights Foundation, and executive director of the Eile Wiesel Foundation. Mr. Phillips is author of *From Bullets to Ballots: Violent Muslim Movements in Transition* (Transaction Press, 2008), *Losing Iraq: Inside the Postwar Reconstruction Fiasco* (Perseus Books, 2005), *Unsilencing the Past: Track Two Diplomacy and Turkish-Armenian Reconciliation* (Berghahn Books, 2005), *The Kurdish Spring: A New Map For The Middle East* (New Brunswick, N.J.: Transaction Publishers, 2015), *An Uncertain Ally: Turkey Under Erdogan's Dictatorship*(Forthcoming). He has also authored many policy reports, as well as more than 100 articles in leading publications such as the *New York Times*, *Wall Street Journal*, *Financial Times*, *International Herald Tribune*, and *Foreign Affairs*.

コロンビア大学人権学研究所 (ISHR) 平和構築・権利プログラム・ディレクター。国連事務局シニアアドバイザー、アメリカ国務省外交エクスパート・シニアアドバイザーで、ハーバード大学中東研究センター客員教授、コロンビア大学国際紛争解決プログラム常任理事、アメリカン大学紛争予防・平和構築プログラム・ディレクター、ニューヨーク大学政治学部准教授、外交官養成アカデミー・ウィーン教授。外交関係予防行動協議会シニアフェロー・副代表、アメリカ合衆国大西洋協議会シニアフェロー、理論国際学センターシニアフェロー、コモングラウンド・ヨーロッパセンター長、オスロ国際平和研究センタープロジェクト長、国会人権基金代表、エリ・ヴィーゼル基金常任理事。著書多数。その他、New York Times, Wall Street Journal, Financial Times, International Herald Tribune, Foreign Affairsなどに100以上の報告を寄稿。

Takashi INOBUCHI, President of University of Niigata Prefecture



In his 40-year professional career, Dr. Inoguchi has covered extensively from Political Theories, Comparative Politics, to International Politics. Especially he has exhibited his prominent research ability by making numerous publications and presentations in and out of Japan in the fields of East Asian International Politics, Japanese Politico-Economic Analyses, Asian Comparative Political System, Japanese Foreign Policy, International Relations Theories, and others. Among his many accomplishments, Dr. Inoguchi has made great strides in empirical research of Japanese Politics, Comparative Politics, and International Politics. Between the two major approaches to political analyses: the Staatslehre Tradition and the Empirical Political Theoretic Tradition, he has followed the latter and has exerted strong leadership among the Japanese Political Science circles in the late 20th and the beginning of the 21st Century. Due to his prolific publication of books and articles both in Japanese and English, he is the most frequently cited Japanese scholar in the fields of Political Science and International Relations according to Google and Scopus citation statistics.

猪口孝 (新潟県立大学学長)

新潟県立大学学長、東京大学名誉教授。東京大学卒業後、マサチューセッツ工科大学にて政治学博士号取得。東京大学東洋文化研究所教授、国連大学上級副学長、日本国際政治学会理事長、日米教育委員会委員などを経て現職。アジア全域の「生活の質」世論調査指導者。専攻は政治学、国際関係論。著書100冊以上。最近では『現代市民の国家観』(東京大学出版会、2010年)、『実証政治学構築への道』(ミネルヴァ書房、2011年)、『ガバナンス』(東京大学出版会、2012年)、『日米中のトライアングル』(ハルグレイブ・マクミラン、2013年)、『データでみるアジアの幸福度』(岩波書店、2014年)、『政治理論』(ミネルヴァ書房、2015年)。

Kazuo ZAIKI, Professor, Graduate school of Integrated Arts and Sciences, Hiroshima University



Sociologist who makes a study of socio-economic problems and social problems in Japan. Current subjects are the problems such as government debt and bonds, reform of the social security, decline in birth rate and marriage rate, support of the elderly, work-family-balance. On the other side, he had study abroad experience in Yugoslavia in the period of socialism (at the Faculty of Philosophy of Zagreb University in Croatia from 1984 to 1986). Since then Zaiki has been continuously engaged in the research of Yugoslavia as an area study. In recent years he has been making rounds of the places of return of refugees and IDPs in Croatia and Bosnia-Herzegovina, doing an interview survey of local residents from sociological point of view. The aim of research is to investigate how ethnic minorities remain and survive in their place of origin against severe consequence of 'ethnic cleansing'. Recent works on this problem are: "Return and reintegration of Serbian refugees in Croatia" (2011), "Anti-discrimination, Integration and Multi-national coexistence" (Maruzen Bookstores 2012), "Current living conditions of minority returnees after the ethnic war" (2013), "Sustainable return of ethnic minorities in terms of generational reproduction" (2014) and others.

材木和雄 (広島大学大学院総合科学研究科教授)

専門は現代社会学と産業社会学。日本の経済社会の諸問題、未婚化・少子化の問題、高齢者介護、ワーク・ライフ・バランスの問題を研究。他面で1984-86年に社会主義時代のユーゴスラヴィア(クロアチア共和国ザグレブ大学哲学部)に留学。それ以来、ユーゴスラヴィアの諸地域を対象とした地域研究を続ける。近年ではクロアチアとボスニア・ヘルツェゴヴィナにおける紛争避難民の帰還地域を定期的に巡回、住民にインタビュー調査を実施し、マイノリティの残留実態を調べている。研究成果として、「クロアチアにおけるセルビア人難民の帰還と再統合」(2011年)、『反差別・統合・多民族共生』(丸善書店、2012年)、『世代の再生産の可能性から見たマイノリティの帰還の持続可能性』(2014年)など。
