〔論文審査の要旨〕 (Summary of the Dissertation Evaluation)			
<p>The dissertation analyzed the participation behavior of tourism activities and social contact during COVID-19 pandemic. The thesis includes nine chapters in total, having Chapter 4-8 the main contents of the thesis.</p> <p>Chapter 1 includes an introduction of the overall research background, research framework, significance and academic contributions.</p> <p>Chapter 2 is a critical review of the existing literature about policymaking approaches and tourism activity participation.</p> <p>Chapter 3 presented the methodology adopted in the thesis as well as the data collection and survey implementation.</p> <p>Chapter 4 presents the analysis of COVID-19-related policies in the context of China.</p> <p>Chapter 5 presented the results of tourism activity participation behavior using a latent class model.</p> <p>Chapter 6 presented the results of the negative binomial regression model for modeling the number of contacted people and its influential factors.</p> <p>Chapter 7 presented the results of a hybrid choice model with the purpose to analyze the contact mode influenced by attitudes.</p> <p>Chapter 8 presented the results of a copula-based model with the purpose to analyze the contact mode and the number of contacted people.</p> <p>Chapter 9 concludes and summarizes the findings of the whole thesis, with some discussions on possible future research.</p> <p>Based on the evaluation of the dissertation, it has been concluded that the research work is innovative, and conclusions are supported by the data and the applied approaches. Content-wise, the dissertation is rich in information regarding tourism activity and social contact behavior during the COVID-19 pandemic.</p> <p>Based on the above justification, as a result of the examination, the author of this dissertation is deemed to be sufficiently qualified to be awarded a doctoral degree (Doctor of Philosophy).</p>
